Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

James Hinton (I):

We need health care. However 99% of us want affordable, quality health care. We want single payer health care. Get rid of third party parasites in our health care system. Money should go from the patient to the doctor/pharmacist, not to a black hole of corporate lobbyist/drug dealers. Cost-cutting will be achieved through eliminating exorbitant corporate profits, through administrative reform and above all through a federally-funded program of biomedical research designed to discover new and more effective treatments and cures for the principal diseases currently afflicting humanity.
