Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Barbara J. Lee (Dem):

Social Security is an essential social safety net, providing critical income to more than 53 million retirees, workers with disabilities, spouses and their children. I strongly oppose efforts to make huge cuts to social security in an effort to balance our budget and I believe that such efforts are misguided and morally wrong; we must not balance the budget on the backs of our seniors and the vulnerable[...] Lastly, I strongly oppose any efforts to privatize Social Security and believe that there are simple solutions to safeguard social security without reducing benefits. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Barbara J. Lee (Dem):

I cosponsored the Progressive Caucus' Budget For All which would prevent any cuts to Medicare physician payments for a decade, providing a firm foundation to plan and establish a strong, permanent healthcare system that provides people with the health services they need while giving physicians fair payments. Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Barbara J. Lee (Dem):

Dakin M. Sundeen (Rep):

We need to reform the Tax Code. I support a flatter, fairer system, with less loopholes. A simpler tax code would go a long way towards improving prosperity. We also need improvements in our energy and water infrastructure. Upgrading the infrastructure in California would provide well paid construction jobs, and many more for maintenance. The increased water supply will grow agriculture and industry that comes with it. Finally I believe building a class of skilled workers is the way to increasing the middle class.
