## **Social Security**

How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

#### Jim Costa (Dem):

We can cut through the partisan rhetoric with a balanced package that: Implements the Simpson-Bowles recommendations to reduce spending by \$4 trillion over 10 years lower tax rates, ensure the solvency of Medicare and Social Security and stabilize the debt. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

How would you help Americans save so they can secure their future and live independently as they age?

#### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

#### Jim Costa (Dem):

Funds from the American Recovery and Reinvestment Act (Recovery Act) were successful in reaching all three counties across California's 20th District, putting people back to work and improving our communities[...] Whether it is constructing a new and sorely needed bridge in Bakersfield or preventing a firefighter from being laid off, the Recovery Act helped put people to work and make a difference in our communities. As we work to secure more water and keep our economy going, I continue to support tax cuts and common sense measures that benefit our working and middle-class families.
