## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Tony Cardenas (Dem):**

Tony Cardenas has fought hard to bring new jobs to the San Fernando Valley and give small businesses the tools they need to succeed. Cardenas' leadership was instrumental in bringing the new Mission Foods manufacturing plant to Panorama City to create four hundred new local jobs, the biggest infusion of jobs to the valley in more than five years. As Chair of the City's Ad Hoc Committee on Business Tax Reform, Cardenas cut red tape and reduced city taxes to help local small business owners keep the doors open during these difficult times.
