## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Karen Bass (Dem):**

Social Security is one of the most effective programs in our country's history. It serves as a foundation for retirement security that keeps our seniors from living in poverty. Millions of Americans depend on Social Security benefits and the program must be protected and strengthened to ensure its continuation for future generations.
