## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Adam Nick (Rep):**

### **Loretta Sanchez (Dem):**

As your representative, I have worked hard to protect and preserve Medicare and Social Security for Americans. Current and future generations of seniors deserve the best retirement possible and strong but affordable healthcare benefits.

## **Medicare**

*How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?*

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Adam Nick (Rep):**

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

### **Loretta Sanchez (Dem):**

Millions of senior citizens depend on Medicare+Choice (M+C) plans for health care. Reducing payments to Medicare providers does not take into consideration a disproportionate increase in the cost of health care. Representative Sanchez opposes any further cuts in the payments to Medicare providers and supports restoring Medicare funding. ## **Financial Security**

*How would you help Americans save so they can secure their future and live independently as they age?*

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Adam Nick (Rep):**

### **Loretta Sanchez (Dem):**

Congresswoman Sanchez has been a longtime advocate for small business interests, fighting for small business loans and against tax increases that hamper economic growth. She strongly supported the economic stimulus package that continues to encourage investment and boost consumer confidence, all while maintaining the fiscal discipline that will keep long-term interest rates in check. These provisions will play an important role in ensuring business entrepreneurs can acquire the venture capital needed to expand businesses and create new jobs.
