# **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### George Leing (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

#### Jared Polis (Dem):

I support securing Social Security's long-term stability and solvency. Rather than raiding the Trust Fund and mortgaging our future, we must strengthen Social Security by restoring fiscal responsibility. ## **Medicare**

# How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

## George Leing (Rep):

## Jared Polis (Dem):

Congressman Polis does not believe we should balance the budget on the backs of seniors who have funded the program for years with their tax dollars. Medicare has become an indispensible part of our nation's social safety net[...]Medicare unquestionably has succeeded in giving our seniors the opportunity to maintain a healthy and productive standard of living after they retire, and Congressman Polis is committed to working in Congress to develop a plan to ensure the long-term sustainability of Medicare in a way that protects the benefits that our seniors rely on.
