Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Abel J. Tapia (Dem):

Scott R. Tipton (Rep):

I am firmly opposed to privatizing Social Security. If we are to continue to provide future generations with the promise of Social Security, we must engage in a bipartisan debate about genuine reform...Before ensuring solvency for younger Americans, our first priority must be to protect those current beneficiaries and those who have planned their retirements around Social Security benefits. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Abel J. Tapia (Dem):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

Scott R. Tipton (Rep):

Our plan makes responsible budget reforms and begins to pay back the national debt; it ensures that critical programs like Medicare will be available for future generations, and does not change Medicare benefits in any way for current seniors (65 and older) or those 10 years from retirement (55 and older)...I'm committed to keeping the promise to seniors and fighting to protect their access to quality health care, and it's my hope that the President and the Senate will work with us in the House to pass real solutions to the challenges facing our country[...] (Source: Rep. Financial Security

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.
