# **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

# How would you help Americans save so they can secure their future and live independently as they age?

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

## Alan M. Grayson (Dem):

Grayson strongly supports the Stimulus plan and has credited the plan with holding off a depression that would have seen 20% unemployment. Grayson introduced legislation to allow the US Treasury Secretary to set pay levels for all employees for all companies that took TARP money. Congressman Grayson has spoken on numerous occasions about his belief and support of economic policies that use the federal government as the controlling factor in economic stimulus and economic growth.
