Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Vern G. Buchanan (Rep):

Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Vern G. Buchanan (Rep):

[...] Key Federal safety net programs, such as Social Security and Medicare, must be protected and their long-term solvency be ensured to help retirees and seniors in their post-employment years. We need a non-partisan Blue Ribbon Commission to make recommendations about how best to guarantee Social Security and Medicare's long-term future. In the early Reagan Administration, the "Greenspan Commission" helped save Social Security for 30 years. We need a 21st Century version of this to help keep Social Security and Medicare safe for the Baby Boom generation. (Source: Congressman Vern Buchanan official Website, <http://ow.ly/y6oNf>)

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Vern G. Buchanan (Rep):

[...]I've introduced the "Buchanan Jobs Plan" in Congress to help restore the economy and get America working again. Some of the provisions include:[...]restructure our tax system to make it simpler, fairer, and less burdensome to any would-be entrepreneur...Abolish unnecessary government regulations on employers that drive up costs while keeping job growth down[...]A Balanced Budget Amendment will help stabilize our economy[...] legal reform that discourages frivolous lawsuits that drive up costs on small businesses and consumers[...] Repeal the new, heavy-handed requirement that all businesses buy health insurance for their employees.
