Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Carl J. Domino (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

Patrick E. Murphy (Dem):

I will oppose any change to Social Security and Medicare that will negatively impact our seniors. Seniors today are under an unacceptable strain – with Medicare costs continuing to rise and a Congress that's intent on undermining Social Security. The single biggest and most immediate threat to Social Security is not solvency, but rather the continual assault on the program by those that wish to privatize it, means test it, or divert it into pet programs.... Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Patrick E. Murphy (Dem):

Congress must take strong and deliberate steps to create a better environment for job growth by doing the following: • End the tax loopholes that let corporations hide profits overseas and invest those dollars in small businesses that create jobs here in America. • Provide tax cuts to small businesses and expand lending so businesses of all sizes can create new jobs. • Invest in a clean-energy economy and provide tax credits to spark manufacturing of windmills, solar panels, electric cars... • Put Americans to work rebuilding our roads, bridges, railways, and ports (Source: Patrick Murphy for Congress, <http://goo.gl/cocmLj>)
