## **Social Security**

How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

# How would you help Americans save so they can secure their future and live independently as they age?

#### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

#### Curtis J. Clawson (Rep):

The first lesson to be learned is that the private sector is the only way to create productive jobs to create real prosperity. Government is ineffective at creating jobs and has zero ability to "stimulate" job creation on its own. If a stimulus strategy were truly effective, America would be awash in jobs today – but, of course, we are not. In 2009, Congress passed a stimulus bill. #### April J. Freeman (Dem):
