Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Charles A. Long (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

John P. Sarbanes (Dem):

Social Security has made it possible for millions of Americans to live with security and dignity in their retirement. It has also provided a safety net for widows, children who have lost a parent, and disabled workers. For these reasons, Congressman Sarbanes strongly believes that we must keep our commitments to retirees and provide them with the income security that they were promised, while making the common sense reforms to ensure the program's long term solvency. Medicare

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.
