### **Social Security**

How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

#### Richard E. Neal (Dem):

Social Security is a bedrock principle...Actuaries have certified that Social Security is in good condition until 2033..My argument is that we want to encourage people to use the tax code to save more or in addition to Social Security but never as a substitute. ### Medicare

# How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

#### **Richard E. Neal (Dem):**

Upon entering Congress, I pledged to be the strongest advocate for preserving and protecting Social Security and Medicare and I still believe they are sound principles for taking care of our seniors. # How would you help Americans save so they can secure their future and live independently as they age?

#### **AARP's Position:**

#### Richard E. Neal (Dem):

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

I have voted to raise the debt ceiling twice because I did not want to see the United States default on its debt for the first time in history. But I did not vote for the latest plan because I simply do not believe the agreement reached is fair and balanced. The deal opens the door to future cuts in Social Security and Medicare. And it puts future funding for education, hospitals and law enforcement at risk. In fact, the burden of the spending cuts falls squarely on the backs of the middle class and seniors. (Source: R.
