Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Douglas J. Daggett (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

Keith M. Ellison (DFL):

There are ways to strengthen Social Security that don't cut the benefits millions of seniors depend on. In 2008, President Obama proposed raising the income cap on the Social Security payroll tax. Just by asking wealthy Americans to contribute to the Social Security trust fund from all of their income, as middle-class Americans already do, we can make Social Security solvent for 75 years. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Douglas J. Daggett (Rep):

Keith M. Ellison (DFL):

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Douglas J. Daggett (Rep):

Keith M. Ellison (DFL):

Keith's top priority in Congress is job creation. With millions unemployed and millions more under-employed, we must get America back to work. Keith understands that having a job provides vital income, but it also means pride and dignity for workers and their families. Keith has stood up for job creation by helping author legislation such as the Local Jobs for America Act, which would create one million public and private sector jobs in local communities. This bill sends resources directly to states and municipalities with the greatest number of people out of work to restore vital local services.
