# **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### Martin D. Baker (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

### Lacy Clay Jr. (Dem):

I am committed to working with my colleagues in Congress to take fiscally responsible measures that will make Social Security permanently solvent by addressing its long-term challenges... I have cosponsored H.R. 235, the Social Security Fairness Act of 2009 which would amend title II of the Social Security Act to repeal the Government pension offset (GPO) and windfall elimination provisions to protect retirees. I also cosponsored H.R. 3954, the Social Security COLA Protection Act of 2005 aimed at protecting Social Security cost-of-living adjustments (COLA). ## **Medicare**

# How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.
