Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

John Lewis (Dem):

Lewis will stand firm against efforts to pull the rug out from under seniors who have worked hard and paid their fair share to support [...] Social Security. Lewis disagrees with efforts in the House to fundamentally change or dismantle [...] Social Security. People across the nation work hard and pay their fair share to support [...] Social Security with the promise that those programs will be there for them when they retire. Lewis believes passing a budget that includes common-sense reductions in wasteful spending is vital while ensuring we honor the promises of [...] Social Security. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

John Lewis (Dem):

If given the opportunity to serve Montana in Congress, I will work with anyone willing to join me to reauthorize the Older Americans Act and stand firm against any attacks on Medicare. And, I will keep the stories of the people I met in the Billings Heights with me as a reminder of the duty we have to reduce the deficit, while making sure the burden isn't placed squarely on the shoulders of our seniors. In Congress he will champion efforts to bring back manufacturing to America by closing tax loopholes that make it easier to for corporations to ship jobs overseas.
