# **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

## Marilinda J. Garcia (Rep):

No serious plan for ending debts and deficits can ignore the need for entitlement reform. The Bowles-Simpson commission proposed a number of common-sense proposals. I endorse much of its work, but believe more must be done. Specifically, I believe entitlement reform must include block-grants to the states, so the federal government can rein in spending and states gain the flexibility to administer programs more effectively. ### Ann McLane Kuster (Dem):

Standing up for Social Security and Veterans Benefits: I will not vote to cut benefits to these vital social programs. Working together, both parities must ensure that New Hampshire families can continue to count on these programs for generations to come. I am a cosponsor of a resolution (H.Con.Res 34) expressing that the Chained Consumer Price Index, which would lower benefits for seniors, should not be used to calculate cost of living adjustments for Social Security and veterans benefits. # How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.
