Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Garry W. Cobb (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

Donald W. Norcross (Dem):

"Let me be crystal clear: As Congressman, I will fight any [...] attempt to privatize all or part of Social Security or turn Medicare into a voucher program that could significantly drive up the costs for our struggling seniors – many of whom live on fixed incomes." Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Garry W. Cobb (Rep):

Donald W. Norcross (Dem):

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Garry W. Cobb (Rep):

"We will need to look out for and help our senior citizen neighbors. As community members, we should make sure that they're okay before we leave for work each morning, and we should develop the habit of checking on them when we come home from work." (Source: GarryCobb.com <http://ow.ly/xZooK>)

Donald W. Norcross (Dem):

[...] I have advocated to continue the Senior Property Tax Rebate, which provides our retired residents with a much needed break on property taxes. (Source: Norcross Campaign Site <http://ow.ly/xCPAk>) [...] Norcross [introduced] The Caregiver's Assistance Act [which] provides gross income tax credit for certain expenses paid for or incurred in the care and support of a senior family member. "Caregivers never get a holiday, but they do deserve a break," said Senator Norcross. "Providing long term care for a loved one is a tremendous task that often takes a toll.
