## **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### Ruben M. Scolavino (Dem):

If elected I would focus my efforts to protect the Social Security program for those who are currently in the program and to ensure that generations to come will be able to retire without having to fear poverty. I will oppose any effort to privatize Social Security. We should not have to expose the benefits of those who have worked so hard during their lives to the fluctuations of the stock market [...] there will be no further cuts to those benefits. By increasing the tax burden on the top 1% percent we will be able to maintain this system [...] without increasing government deficits. (Source: Town-hall, Ocean, NJ March 10)

### Chris H. Smith (Rep):

## **Medicare**

# How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

#### Ruben M. Scolavino (Dem):

According to statistics nearly 50 million Americans rely on the Medicare program to help them with medical expenses. It is imperative that these benefits be protected at all costs, especially from proponents of the "Ryan Budget". I will continue my fight to prevent privatization and to finally eliminate the "doughnut hole" that costs seniors so much of their hard earned income. ### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### Ruben M. Scolavino (Dem):

I will work hard to ensure that our economy becomes second to none. Providing benefits to companies who keep jobs in this country and establishing relationships with other economies that will benefit our citizens. The Living Independently for Elders (LIFE) program, run by St. Francis Medical Center, now enables nursing-home eligible seniors to obtain all inclusive, customized, quality medical services, nutritional and pharmaceutical assistance and other care they desperately need without having to move to a nursing home.
