## Social Security

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Bill J. Pascrell Jr. (Dem):**

Continually working for the protection of Social Security, Bill has fought against efforts to privatize the program. Privatization means that your Social Security funds that you earned over a lifetime of work would be placed in the private market and subject to its volatility... Considering many seniors lost part of their retirement savings when the market fell, had Social Security been privatized, these seniors would have faced poverty.
