Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Jefferson L. Byrd (Rep):

We must keep the promises we have made to our seniors by protecting Medicare and Social Security. [...] I refuse to play class warfare with our seniors' retirement fund. We can protect the solvency of these programs by means testing, altering age requirements for new enrollees, and securing programs for future generations. Ben Ray Lujan (Dem):

Luján called any plans for privatization of Social Security or Medicare "dangerous ideas" that are too risky. "We need to be looking after Social Security and protecting it, and this notion of gambling with it in the market by privatizing it is a bad idea," Luján said. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Jefferson L. Byrd (Rep):

My main focus when I get to Washington is to fight for and introduce legislation that will stimulate America's economy and get New Mexicans back to work again. I will work to implement an ambitious "New Jobs New Mexico" plan that will reduce regulations and boost private sector jobs in industries important to Northern New Mexico. Simplifying our tax code and regulatory system will go a long way to creating a climate where businesses can grow and thrive.
