## **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

#### Kathleen M. Rice (Dem):

Oppose Privatization — Kathleen will fight back against all efforts to privatize Social Security and dismantle the most effective, financially healthy social insurance program we have in this country. Oppose Benefit Cuts — [...] Kathleen will fight back against wealthy special interest groups seeking to balance the budget on the backs of seniors, disabled workers, and low-wage earners. Improve Cost-of-Living Adjustments — Kathleen will work to correct cost-of-living adjustments to account for rising healthcare costs so that all seniors can live with dignity and access to high-quality medical care. Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

## **Financial Security**

# How would you help Americans save so they can secure their future and live independently as they age?

#### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### Bruce A. Blakeman (Rep):

We need to get America moving again and create jobs. The following are a few things that can be done to expand the economy and create jobs: Simplify the tax code and reduce the tax burden of job creators and the hard-working middle class; Repeal Obamacare. It is a jobs killer and a tax on the middle class. [...] Invest in smart jobs training for the new economy. There is too much bureaucracy and overlapping in jobs training programs. #### Kathleen M. Rice (Dem):

New York's income inequality gap is the highest in the nation, with millions of low-wage workers struggling to meet our state's skyrocketing costs of living.
