# **Social Security**

How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### Charles B. Rangel (Dem):

Thanks to Social Security, millions of seniors can live their lives with dignity and independence...I stand firmly...in opposing any efforts to privatize these programs. I reject the idea that the future of hard-working Americans should be subject to the volatility of financial markets...We should not cut taxes for the wealthiest Americans at the expense of gutting the lifeline that helps millions of Americans to survive. #### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

We must spur job creation by strengthening the pillars that have made America great: by investing in education, by helping small business owners and entrepreneurs, and by encouraging innovation.
