Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Marcy C. Kaptur (Dem):

Several policies have been suggested to offer a more accurate measurement of change in the cost of living. One example is to create a new CPI especially for seniors, which would take into account their higher costs for health care, prescription drugs, and other goods and services. Another is to compensate seniors with a \$250 payment in years where there is no COLA. I have cosponsored a bill, the Preserving Our Promise to Seniors Act, which would do both these things. This bill would also phase out the cap on Social Security payroll taxes, to help ensure that Social Security is solvent for years to come. (Source: Marcy Kaptur House Website, http://ow.ly/csC4C)

Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Marcy C. Kaptur (Dem):

I believe in protecting Medicare for all citizens. Medicare represents a covenant between the U.S. government and its citizens, regularly acting as a lifeline for our seniors. Knowing this, Congress crafted a provision in the Patient Protection and Affordable Care Act, which was signed into law on March 23, 2010, to extend the solvency of Medicare by nine more years.
