Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Matthew A. Cartwright (Dem):

The dignity of our seniors is at the forefront of Congressman Matt Cartwright's policies. As an admirer of President Franklin Delano Roosevelt, Congressman Cartwright is fighting hard to ensure that Social Security provides benefits for not only our nation's grandparents, but their grandchildren as well. Social Security has dramatically reduced senior poverty for nearly eighty years, and the Congressman will oppose efforts to privatize the benefits of the program or take risks with its trust fund. David J. Moylan III (Rep):

He is less decisive on Social Security and Medicare. He said the issues need to be studied and any changes affecting Social Security beneficiaries would affect those entering the system. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Matthew A. Cartwright (Dem):

In the case of Medicare, recent legislation has made significant additions to the program in which will add years of viability. These changes are a good start, but Congressman Cartwright knows that further modifications are necessary to continue this program for the infinite future. Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Matthew A. Cartwright (Dem):

"[Legislation I sponsored] would help improve the care offered by direct-care workers and lower care costs for both older Americans and the health care industry." "This legislation will improve the quality of care for seniors living at home by expanding the training and support of the direct care workforce that care for these seniors," Senator Casey said. We must fully tap into our rich abundance of coal, oil and natural gas, including the construction of the Keystone XL pipeline, which will not only break our dependence on foreign energy but also create tens of thousands of good-paying jobs. If U.S. consumers were to consume just \$100 billion more U.S. -made goods, that would create more than 1 million new American manufacturing jobs.
