## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

## **Medicare**

*How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?*

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Phillip H. Black (Dem):**

Use the current Medicare billing system for all private insurance companies (would cut overhead cost by 30% or more). (Source: Black fro Congress, <http://ow.ly/ygdmk>)

## **Financial Security**

*How would you help Americans save so they can secure their future and live independently as they age?*

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Phillip H. Black (Dem):**

Use the 2 billion dollar grant to Haiti and send unemployed USA construction workers to rebuild and the same Economy will aid USA as the workers from Mexico assist the Mexican economy. Plus use USA products in the rebuild. (Source: Black for Congress <http://goo.gl/su5oGQ>)

### **Joe Wilson (Rep):**

In order to increase national employment and put our economy back on the path to prosperity, our nation must maintain a strong right-to-work workforce. [...] Throughout my work on the House Committee on Education and Workforce, Chairman John Kline and I have fought to hold the National Labor Relations Board accountable by cracking down on their attempts to restrict union workers' access to secret ballot elections.
