## Social Security

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Thomas A. Adams (Dem):**

### **Mick Mulvaney (Rep):**

I am committed to doing whatever it takes to protect Social Security for those who planned their lives [...] around the promise that they will receive its benefits. When the social security program was begun in 1935, more than half of America's senior citizens were living in poverty. [...] I am also dedicated to making sure that future generations benefit from a viable retirement system. Some politicians [...] have favored privatizing social security. I disagree with that approach as a cure-all. Instead, I look forward to working to find a comprehensive solution that keeps social security both solvent and sustainable. Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.
