Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Joe L. Barton (Rep):

...begin by stopping the use of Social Security funds for anything other than Social Security... I believe that whatever shape the final reform takes, it must include an option for younger workers to set aside a portion of their payroll tax in a personal savings account. Allowing workers to take responsibility for their own retirement creates a sense of ownership and reduces the dependence on government. Individual accounts would also prevent the government from using surplus Social Security revenues to "mask" public borrowing, or for other spending or tax reductions. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Joe L. Barton (Rep):

I will continue to push to roll back mandates and replace them with cost saving choices for consumers including... Protecting Medicare and Medicaid for those who currently depend on them, while preserving the programs for future generations (Source: Joe Barton for Congress; <http://ow.ly/ce6Ot>)

David E. Cozad (Dem):

Financial Security

How would you help Americans save so they can secure their future and live independently as they age?

AARP's Position:

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

Joe L. Barton (Rep):

It is time to put Americans back to work. The best thing Washington can do is get out of the way so our nation can do what it does best: create, innovate, and lead. I have joined my colleagues to support the Plan for America's Job Creators. It is a pro-growth agenda that doesn't raise taxes on working families or small business owners.
