## Social Security

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Kay M. Granger (Rep):**

Over the past few years, Congress has taken steps to improve the management and accounting of the Social Security trust fund. However, more action is needed to ensure Social Security is available for tomorrow's seniors. I believe that any changes in the way Social Security operates must be approached with extreme caution. ## Medicare

*How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?*

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Kay M. Granger (Rep):**

Congress needs to act in a bipartisan fashion to protect and preserve these vital programs. Medicare and Medicaid need good management and innovative ideas to ensure they remain solvent. Prudent actions now will save taxpayers money in the long term while meeting the health care needs of those who cannot care for themselves and millions of seniors. ## **Financial Security**

*How would you help Americans save so they can secure their future and live independently as they age?*

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Kay M. Granger (Rep):**

One of the best ways to help improve our economy is by injecting money directly into the hands of taxpayers. I am a cosponsor of H.R. 143, a bill introduced by Congressman Gohmert that would create a two-month "tax holiday." During the tax holiday, workers would not have to pay federal income taxes, and would instead take that money home in their paycheck.
