## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Ruben E. Hinojosa (Dem):**

Congressman Hinojosa is an advocate for the federal programs that America's seniors depend upon. He strongly believes that Social Security and Medicare are promises of health and quality of life for the elderly. That is why he has spent his time in Congress fighting to strengthen and preserve these programs... Hinojosa will continue to fight for Medicare and Social Security, ensuring their ability to serve future generations. ## **Medicare**

*How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?*

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Ruben E. Hinojosa (Dem):**

Congressman Hinojosa opposes the...proposal that would end Medicare as we know it by changing it from a guaranteed benefit plan to a voucher system. Seniors would be forced to find a private insurance company and hope their government subsidy would pay the cost of the premium. If it didn't, they would have to pay the difference. ## **Financial Security**

*How would you help Americans save so they can secure their future and live independently as they age?*

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Ruben E. Hinojosa (Dem):**

In addition to promoting job creation and job training opportunities, Hinojosa is committed to protecting America's workers' rights. He fought the Department of Labor's proposal to change the overtime regulations, effectively denying millions of Americans the right to earn overtime wages. He fought off attempts to replace overtime wages with compensatory time – a move which could drastically reduce family earnings. He supports workers' rights to collective bargaining and a living wage. During the 110th Congress, Hinojosa supported the passage of the first increase in the minimum wage law in more than a decade.
