## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Lamar S. Smith (Rep):**

Social Security must be protected. Its Board of Trustees projects that its trust funds will be depleted in about twenty years. This is expected to occur because of rising costs associated with Social Security and the impending retirement of the baby-boom generation. I firmly believe that the federal government must take an active role to secure Social Security's future. Seniors may rest assured that their benefits are safe and secure. ## **Medicare**

*How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?*

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Lamar S. Smith (Rep):**

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

## **Financial Security**

*How would you help Americans save so they can secure their future and live independently as they age?*

### **AARP's Position:**

More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

### **Lamar S. Smith (Rep):**

Small businesses, which have created 66% of all new jobs in the past 15 years, aren't going to hire people when they are worried about paying higher taxes and facing more government mandates. With all the talk coming out of Washington, who would take that risk? Congressman Smith believes that when Washington eliminates the looming threat of more taxes, more spending and more debt, American entrepreneurs will have an incentive to invest in their businesses and put Americans back to work.
