## **Social Security**

*How would you protect Social Security for today's seniors and strengthen it for future generations?*

### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

### **Henry R. Cuellar (Dem):**

"Our nation made a promise to Americans 75 years ago to compensate a lifetime of hard work and dedication. We must not compromise these financial benefits for the more than 3 million seniors and other beneficiaries in Texas," said Congressman Cuellar. "That's why I'll continue to protect this important program and its fiscal solvency for the long-term. ## **Medicare**

### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

### **Henry R. Cuellar (Dem):**

While I am willing to work in a non-partisan manner to continue debt and deficit reduction talks, dismantling health security that thousands of individuals have worked a lifetime for is negligent. I will continue my work on behalf of seniors to ensure that Medicare, a promise made to seniors 45 years ago, will be there for our children and future generations.
