Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

I believe jobs are created by a thriving free enterprise system, not by the government. Indeed, our government has done much to stymie entrepreneurship. We must implement pro-growth policies to provide incentives for the creation and growth of businesses. This will create jobs and help regenerate our economy. This will best be done, not by creating tax breaks and tax havens for some; not by creating minimum wage jobs; but by creating secure high paying jobs for as many people as possible.
