Social Security

How would you protect Social Security for today's seniors and strengthen it for future generations?

AARP's Position:

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

Dave G. Reichert (Rep):

I am on the record as saying, many times over, that I support preserving the current Social Security system, AS IS. That is, there are some problems that must be addressed, and I am open to exploring them, so long as it: -Does NOT privatize the system -Does NOT reduce benefits in any way -Does NOT raise the retirement age -Does NOT raise taxes This is fundamental and foundational to any reform in the Social Security system. Medicare

How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

AARP's Position:

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

Dave G. Reichert (Rep):

Without a permanent repeal of the SGR, seniors are in perpetual danger of losing access to their doctors. [...] Medicare physicians could experience a nearly 24 percent cut to their reimbursement which could lead some providers to drop out of the Medicare program [...]. HR 4015 would keep that from happening now and in the future – offering seniors stability and providing certainty to doctors [...]. It is important that we take this step to strengthen and improve the Medicare program. The bill ensures Medicare is focused on the quality of care and senior's health outcomes, not the number of appointments on their calendar. (Source: Reichert House Website, http://ow.ly/yIcPF)
