## **Social Security**

# How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

#### Doug Basler (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

#### Adam Smith (Dem):

I am a cosponsor of the Strengthening Social Security Act, H.R. 3118, which would increase benefits for Social Security beneficiaries while also further strengthening the financial standing of the program's trust fund. This bill would phase out the current taxable cap to ensure that resources are available for future generations to receive the benefits they earned. The legislation also changes the way cost of living adjustments (COLA) are calculated to better reflect the needs and increasing costs of healthcare for seniors. It makes these changes while also improving the long-term solvency of the program. (Source: Smith Congressional Site, http://ow.ly/xVPOY)

### **Medicare**

# How would you put Medicare on stronger financial ground and protect today's seniors and future retirees from rising health costs?

#### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

#### Doug Basler (Rep):

AARP did extensive research but was unable to find any public statement on this issue by July 11, 2014.

#### Adam Smith (Dem):

Many providers in our state do not accept Medicare patients because of these low reimbursement rates, while all others have to charge non-Medicare patients more to offset the losses caused for treating Medicare patients. This must be changed. (Source: Smith Congressional Site, http://ow.ly/xVPOY)
