## **Social Security**

How would you protect Social Security for today's seniors and strengthen it for future generations?

#### **AARP's Position:**

Social Security should continue to guarantee that Americans who work and pay into the system receive benefits based on what they earn and contribute. Benefits should keep up with inflation and last for as long as an individual lives. We must strengthen Social Security for the future and protect benefits for people who count on them most, including surviving spouses and families, lower-wage workers, and disabled individuals who no longer can work. Social Security must be put on stable financial ground, but any adjustments should be implemented gradually so changes do not impact those in or near retirement.

#### Tom Cotton (R):

Tom Cotton supports NO changes to Medicare or Social Security for those currently receiving benefits or for those nearing retirement. For younger workers, Tom Cotton favors commonsense reforms that will strengthen and preserve Medicare and Social Security for future generations. #### **AARP's Position:**

Medicare should be strengthened and improved so both current and future generations can count on having access to high-quality, affordable coverage. Medicare should continue to guarantee a specific set of benefits that are affordable and meet a person's health care needs. Medicare should offer choices that ensure access to high-quality health care. Medicare should improve the quality, safety, and efficiency of care by emphasizing value and cracking down on fraud, waste, and abuse.

## **Financial Security**

How would you help Americans save so they can secure their future and live independently as they age?

#### **AARP's Position:**

#### More opportunities and incentives should be available for all Americans to plan and save so they can have a more secure future. Freedom from age discrimination is a fundamental right and critical to Americans' ability to have a secure retirement. Every worker should be treated fairly, regardless of age. We need to support family caregivers who make it possible for more seniors to live in their homes and communities, where they want, rather than taxpayers and struggling families paying for costlier care.

#### Tom Cotton (R):

In Congress, I will support pro-growth policies that give the private sector the confidence and certainty to start hiring again. Job creators need a tax code that is permanent, fair, and simple with low rates. They need federal bureaucrats to get off their backs and stand by their sides. #### Mark L. Pryor (D):

I remain a strong supporter of legislation to reauthorize programs under the Older Americans Act.
